



Paycheck Protection Flexibility Act

Earlier today, President Trump signed the Paycheck Protection Flexibility Act into law.

Thank you again for all of your efforts over the past several weeks to advocate for these important changes.

While the legislation extends aspects like the 24 week period, June 30th is the final day for those who have not previously (you cannot get two) received a PPP loan to be issued one.

You may want to speak with your lender right away if they are interested in applying, given the June 30th deadline.
